House rules

- All campers and visitors are kindly requested to report to the reception upon arrival.
 - Visitors are subject to a visitor fee. Visitors must leave the premises by 10:30 PM.
- Overnight stays are only allowed for registered guests. Of course, your visitors can stay overnight as well. The applicable rates are listed in the price list. As a camper, you are responsible for your visitors.
- Subletting must always be reported to the reception in advance.
- For tourist camping, arrival is after 2:00 PM, and departure is before 12:00 PM. For rental accommodations, arrival is after 4:00 PM, and departure is before 10:00 AM.
- · Your camping equipment must be placed no more than half a meter from the forest edge.
- Only breathable ground mats are allowed in front of the caravan awning. When absent, the mat must be rolled up or removed to protect the grass under your tent or caravan. The use of root cloth is not permitted.
- The awning may be a maximum of 3.5 meters deep. Any canopy may only be enclosed at the sides and must be removed during long absences.
- For stays longer than six weeks, guests are expected to keep the grass around their caravan short.
- The installation of sheds, extensions, fences, as well as cutting or pruning trees and laying tiles without permission, is prohibited. Digging holes or trenches for tents is not allowed due to water, gas, and electricity lines.
- Satellite dishes are not allowed unless they are permanently attached to your camping unit.
- Caravans without a valid registration certificate are not permitted.
- In case of early departure, all rights to the pitch expire. This also applies to failure to meet payment obligations on time.
- Park your car in your designated spot. If this is not possible, it must be parked in the central parking area. This also applies to company vans.
- Charging electric cars is not allowed within the park. This is only possible at designated charging stations, located at the parking lot near the pond.
- Our park has limited camera surveillance.
- Please keep the premises and buildings clean and undamaged. In particular, we count on your cooperation in the sanitary facilities:
 - o Children under 6 years old may not enter the sanitary buildings without supervision.
 - o Please empty (chemical) toilet buckets only in the designated areas at each sanitary building.
 - o Smoking is prohibited on the swimming pool terrace and in all buildings.
- Children without a swimming certificate may not enter the swimming pool without supervision. There is no lifeguard at the pool or fishing pond!
- The area between the campsite shop, swimming pool, Storm & Sterre Playground, and the entertainment area is a pedestrian zone.
- Only designated accessories may be used on the interactive play wall in the Storm & Sterre Playground.
- Use tap water sparingly. Watering gardens and washing cars is not allowed.
- The waste container is only for household waste and may be used only during designated opening hours. Bulky waste must be disposed of by guests themselves.
- The use of heating appliances not suitable for camping is prohibited.
- Unaccompanied young travelers are not permitted.
- Dogs are not allowed. Cats must be kept on a leash.
- Cars and motorcycles may not exceed a speed of 5 km/h (walking pace). Please drive on paved roads and over speed bumps.

 Unnecessary driving on the premises is not allowed. Mopeds may only be brought onto the premises with the engine switched off.
 - The traffic laws regarding 'residential areas' apply within our park, meaning pedestrians always have the right of way.
- $\bullet\,$ The use of electric scooters, fat bikes, segways, or hoverboards is not permitted.
- The entrance barrier is closed from 10:30 PM to 7:30 AM. From 10:30 PM onwards, the campsite must be quiet. Please behave in a manner that does not cause disturbance to others. Be considerate of one another.
- Be careful with fire! Fire pits are not allowed. If barbecuing, do so before 9:00 PM and keep at least a bucket of water within reach. Please check at the reception if there is a general barbecue ban in effect.
- In the low season, the restaurant and shop have limited opening hours.
- If you intend to sell your camping unit on our premises, the manager must be informed. Once notified, your camping unit may no longer be rented out. Upon sale, all rights to the pitch expire. Any extensions and all tiles must be removed. Signs stating 'for sale' or 'for rent' may not be visibly displayed at the tent or caravan.
- · We are not liable for loss, theft, or damage to guests' or visitors' property, nor for any accidents that may occur.
- Participation in all activities is at your own risk and is only intended for registered campers.
- We adhere to the Recron terms and conditions.
- Everyone is expected to be aware of the house rules. In situations not covered by these rules, the manager has the final say.
